12/07/2018	Commander Ron Brooks	Jamie R. Schultz, came into the PD demanding to talk to someone about her case. Sgt. Miner went out to talk to her. After he talk to her he contacted me and told me that she was demanding to talk to me. He told me that she was angry because during their conversation he said he could not perform a amercyl for her. He said that she told him that we never forwarded the medical records in her husbands case to the prosecutor. I talked to Schultz and she said she wanted to complain that Sgt. Miner was treating her like she was scum. She said that she recorded the conversation and asked if I had a

Samsung charging cord so she could show me the recording. I told her no and gave her my card and told her that she could send it to me by email.

I told her that she would need to obtain the additional medical records that the prosecutor was requesting and forward them to him. She told me that we have all of the medical records we need. I told her that we do have the two original medical records and that they have been sent to the prosecutor but she needs to get the follow-up Dr. appointment records and forward them to the prosecutor. She insisted that those were not needed. I told her that they are needed. At the end of our conversation she agreed to get the follow up records and take them to the prosecutor herself. She said that she was told by the prosecutor that they did not get any medical records.

After talking to the prosecutors office they said that they do have the two medical records that we forwarded but they need the third set. It appears that the prosecutors office has not filed any charges at all in this case not even misdemeanor charges.

I talked to Records Specialist Kathy, I asked her if Sgt. Miner was rude to Schultz. She told me that he was not rude in any way to her.

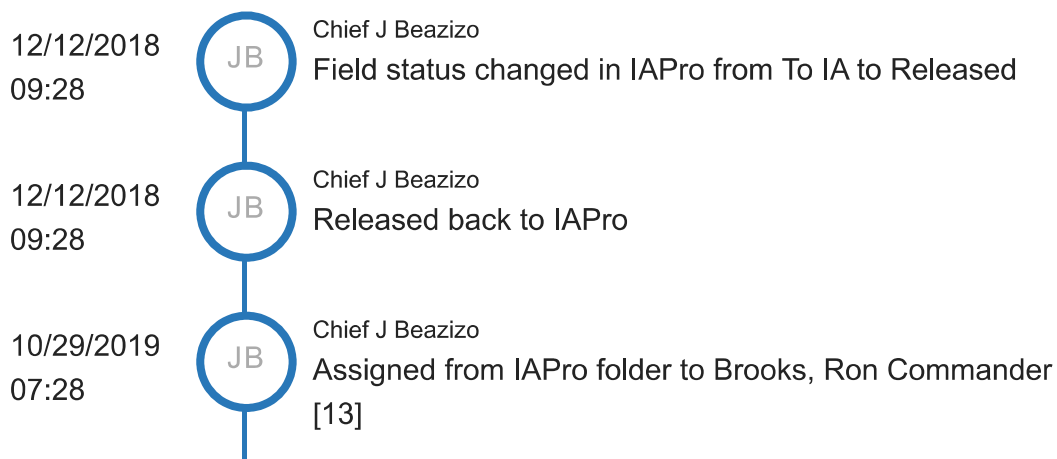
I told Schultz that she could submit a records request to obtain copies of everything we have on her case.
