07/14/2019	Sergeant James Barnes	On 7/11/2019, I received an email from Commander Beazizo asking me to contact Diane Hildebrandt to discuss some concerns she had with Corporal Wells's handling of a recent assault complaint she filed. I did not return to work until 7/14/2019 and called Hildebrandt at the phone number supplied. The time of the call was 1358 hours. I identified myself and provided an opportunity for Hildebrandt to share her concerns with me. Hildebrandt told me that she had filed an assault complaint on 7/9/2019 to which Corporal Wells arrived a short time later to investigate. During the investigation, Wells went to speak with Hildebrandt's son, Gregory Ward, who is 15 years old. During the interaction with Gregory, both he and Hildebrandt felt that some of the comments that Wells made were judgmental concerning the clothing that Gregory was wearing and his "large, poofy" hair. Both Gregory and Hildebrandt felt that Wells was being racist in his comments, as Gregory is ½ black and ½ white (according to Hildebrandt.) Hildebrandt told me that Wells also threatened Gregory with jail if he did not tell the truth about what happened to his mother. This made Gregory feel very uncomfortable. Hildebrandt also

told me that the suspect of the assault was able to overhear their conversation, as she was standing not far from where Wells was conducting the investigation and he (Wells) did not ask her to leave.

After providing an opportunity for Hildebrandt to share her concerns, I asked her how she would like her concerns handled. Hildebrandt told me that she didn't want to get Wells in trouble, but just wanted this documented. Hildebrandt also told me that she wants to be able to call 911 and request assistance without fear or hesitation. She also wants her son to not fear the police. I told her that I wanted those same things and that I would document the incident.

I had earlier spoken with Wells about the case, as he believed that Hildebrandt would file a complaint. Wells shared his investigation with me and the challenges he had with proving that Hildebrandt was assaulted by the neighbor. Wells shared the inconsistencies with Hildebrandt's story, and he wanted to talk with Gregory, as he was home and awake at the time of the alleged assault. Obviously, I do not know the exact conversation that Wells had with Gregory, but Wells did share with me that when he spoke with Gregory, he felt that Gregory had been coached about what to say. At that point, Wells told Gregory to tell him the truth and that lying was a crime. Gregory then changed his story and told Wells that he was in his room and did not see the

alleged assault. Gregory wrote a statement to that effect. The statement is contained in the mentioned case report. Wells also told me that he did not threaten Gregory with arrest, but only told his that lying was a crime.

As part of Wells's investigation, he spoke with the property manager, Ashley Sorenson. Sorenson shared her concerns about Hildebrandt and completed a written statement regarding Hildebrandt's regular complaints about the property management. I attached Sorenson's statement and emails to this review.

I also attached a copy of the full case report to this review to include Hildebrandt's and Gregory's statements.

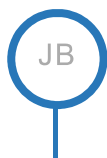
Wells completed a full report on the alleged assault and submitted it to the Snohomish County Prosecutor for felony review.

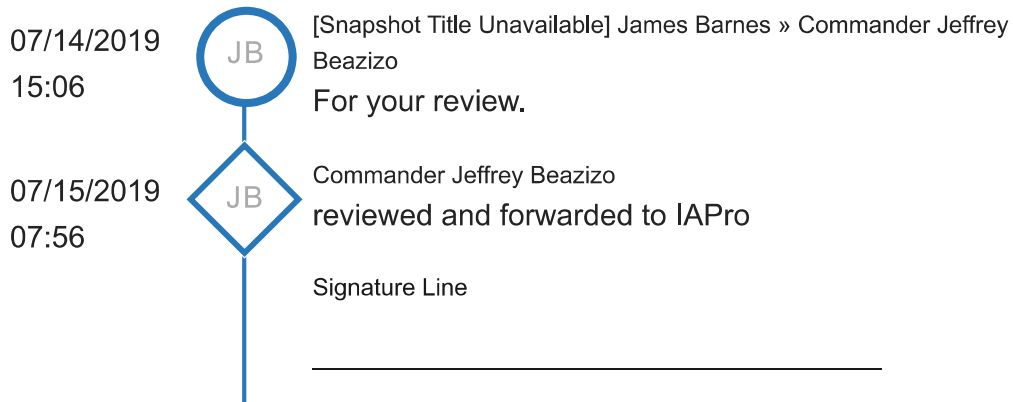

On 7/9/19 at approximately 1211 I, C. Wells #131, was working as a general commissioned uniformed police corporal for the City of Lake Stevens police department driving a marked police vehicle equipped with emergency lights and siren.

Summary:

SCSO Deputy K. Gilje advised he was taking an Assist Agency report from Diane Hildebrandt for an alleged assault that had occurred in the City of Lake Stevens that she hadn't reported to LSPD. He was advised to have her contact me upon her return to Lake Stevens for further investigation.

I met with Diane who told me she had been assaulted by Candice Martin on the morning of 7/8/19 between the hours of 0100 and 0230.

Case forwarded to County Prosecutor for review and charging decision.

Narrative:

On the time and date above I was contacted by SCSO Deputy K. Gilje regarding a Diane Hildebrand claiming she had been assaulted at her residence in Lake Stevens, located at 411 101st Ave SE #G34. He continued by telling me that Diane had claimed the Court recently dropped a temporary Restraining Order between herself and the suspect, Candice Martin.

Deputy Gilje told me Diane was in Court today claiming a new assault had taken place on 7/8/19 and Candice Martin was again the suspect. Deputy Gilje told me that Diane hadn't reported the incident to the LSPD as she didn't believe anything would be done due to a previous assault allegation that had been determined to be inconclusive. Deputy Gilje advised Diane had facial injuries.

I requested Deputy Gilje provide Diane with my name and contact as soon as she returned to the City of Lake Stevens, so I could investigate her allegations. He agreed and advised he would be writing an Assist Agency report.

After hanging up the phone with Deputy Gilje I was handed an Adult Protective Services referral with Diane Hildebrandt as the alleged victim and Candice Martin as the alleged perpetrator. (LSPD 2019-13847) The reporting party for this APS referral was the property manager for Cedar Wood Apartments - Ashley Sorenson.

At approximately 1325, Diane returned home and advised 911 as requested. I arrived at her address within a

few minutes. Upon meeting with Diane, I could clearly see she had bruising under her right eye, on her right cheek and under her chin.

We entered her residence where I interviewed her. Prior to starting the interview Diane handed me the SCSO statement form she had written while talking with SCSO Deputy Gilje.

Diane told me she was sitting crouched down with her head down on her back porch 7/7/19 - Sunday night/Monday morning (sometime between 0100-0230) holding a candle light vigil for friend's that had recently died in a fire in the City of Port Angeles, WA. She continued by telling me she had her head down with her eyes closed while praying and giving blessings when she was struck in the chin by Candice Martin who had some object in her hand.

She told me her head was forced up and back due to the blow. She said she was then struck in the face twice more which caused her to fall forward and onto the patio. When asked if she lost consciousness she told me, "I don't know. Maybe."

She continued by telling me she had lots of blood on her face when she got up off the ground, so she went back inside her residence to clean up. She said she went upstairs to the bathroom and had her son, Gregory (Gregory C Ward DOB:5/28/2004), get her some ice.

Diane allowed me to take several photographs of the injuries. While I was doing this Diane stated her right elbow and foot had also been injured in the assault. I took pictures of these locations as well. When asked how her elbow and foot had been injured Diane told me she didn't know but maybe when she fell forward after been hit.

When asked why she didn't call 911 to report the assault she told me she had no confidence in the Lake Stevens Police department because she had been stabbed fifteen (15) times by Candice in the community laundry room in June. She claimed she reported this event and the Police did nothing.

Reference LSPD case 2019-11510.

LSPD case 2019-11510 was alleged to have occurred on 6/9/19 and was reported the afternoon of 6/10/19. The case was investigated by LSPD Cpl. Fiske from 6/10/19 to 6/25/19. Per the case narrative this incident is considered closed as probable cause wasn't established.

She continued by telling me the case had been closed as inconclusive because Candice's friends had all lied to Cpl. Fiske.

When asked if she knew what the object that was used to hit her was she replied, "It was too dark to see what I was getting it with."

When asked which hand Candice used to hit her Diane became frustrated with me and then responded again that it was too dark and that she couldn't remember.

When asked if it was so dark she couldn't see what she was being hit with or how she was being hit how did she

know it was Candice she replied, "I just know! I know what she looks like!"

I asked her if she saw Candice's face.

She replied, "It was too dark. But it was Candice Martin that assaulted me!"

When asked why she didn't report the assault when it occurred she again said she didn't trust the Lake Stevens police department to do anything, so she just got some ice and laid down.

Diane expressed how upset she was that the temporary Order had been dismissed by the Court because of the last case being closed. She continued by saying the property manager initially wasn't helping her with deal with Candice but since she had been 'stabbed' in the laundry room the Property management is now installing cameras. She continued by saying something to the effect that the manager was responsible for her and her son's safety, but she is undertrained and under educated to be the property manager.

Throughout the interview I had to repeatedly redirect her to the new allegation as she would repeatedly bring up the restraining order being dropped, Candice's friends lying, previous threats from Candice and the alleged assault in June, 2019.

I provided Diane with a LSPD case narrative form and asked her to add information regarding when she sought medical attention. While she was completing this request, I interviewed her son Gregory. I spoke to Gregory privately outside.

Gregory initially started to tell me a similar story as Diane. I stopped him and told him I only wanted to hear what he, himself saw-heard-did. He agreed.

Gregory told me he was playing his video games when at about 2 am his mom went downstairs. He told me that next time he saw her was about 3 when she returned. He said she was stumbling and went into the bathroom. He told me he saw she had some blood on her face but not very much. He said she fell to her knees and he checked on her. He said his mom didn't say much other than telling him to get her some ice which he did.

I then checked the back porch were Diane had told me the assault took place. I checked carefully around the surrounding slider door, welcome mat, concrete pad, table, stool, charcoal BBQ and plants for any item of evidentiary value such as blood spatter, the alleged striking object, etc. I did note what appeared to be ash spilled from the BBQ on the concrete as well as a normal accumulation of dirt and grime on the slider and various items.

I returned inside and verified Diane hadn't cleaned the porch area. She told me she hadn't, and we then went back outside to the porch.

I asked her to show me how she was sitting when she was initially struck. I watched as she sat down on the first step and bowed her head - tucking her shin to her chest. With her bowed she told me her head was down and her eyes were shut while praying and giving blessings.

She kept her head down as she pointed to either side of herself and told me she had lit candles next to her.

She told me was hit in the chin which forced her head up and backwards. While she told me this she showed me physically.

I noted with her head down and chin tucked to her chest I couldn't see her chin or face. I asked if she had been kicked in the face which she denied. She again seemed to get frustrated and told me she knows it was Candice that assaulted her.

She then continued by telling me she was the struck twice (2) more in the right side of her face. She claimed she fell forward onto the concrete. As she did this she pantomimed falling forward and landing on the LEFT side of her body.

I had previously noted there were no injuries to the left side of her face or body which I would expect to see if someone had fallen forward from a crouched position and stuck concrete.

She denied hitting or knocking anything over when she fell.

I pointed out the ash on the concrete and asked where it came from. Diane changed her story and said she had picked the BBQ up as she must have knocked it over.

I pointed out I didn't find any blood spatter on the surrounds as I would expect to see in repeated strikes to a person's head. Diane told me that there wasn't very much blood and that was why there wasn't in splatter.

We returned inside, and I asked Diane if it was possible that she fell and hurt herself due to drinking intoxicants or the effects of her medications. She denied this and again was adamant that Candice had come to her porch and assaulted her.

Diane stated she doesn't drink intoxicants and isn't having any side effects of her numerous medications - one of which is for high blood pressure.

She told me she consumed cold and/or flu Alka-Seltzer the night of the alleged assault.

Diane told me she decided to wait to see a doctor for the injuries until Tuesday as she had an appointment for an unrelated medical condition. She allowed me to photograph the face page of that visit. Additionally, she signed a LSPD Medical release form.

I advised Diane that I would be speaking with Candice as well as the Property manager Ashely Sorenson. I advised her that based on the initial investigation I most likely wouldn't be arresting anyone as the investigation is on-going. She said something to the effect that she understood.

I contacted Candice at her residence. I advised her she was a suspect in an assault and as such I would like to talk with her. She agreed.

I provided her with a LSPD Rights form. I asked her to read it and if she agreed to talk with me fill the form out and sign it. She agreed. She then again told me she has never touched Diane. She told me she is currently physically disabled due to a prior back injury. She retrieved some documentation from her purse and handed it to me.

I reviewed these papers and could see they were medical documents indicated she is currently under a doctor's care for back injuries. She told me she isn't capable of assaulting anyone. She allowed me to photograph the documents as well as her and her hands. Candice continued by telling her boyfriend, Kyle Walker, was at her house throughout the night/morning in question and he would corroborate her story.

Reference Rights Waiver/statement - Candice Martin

I next spoke with the Property manager Ashley Sorenson. She told me there has been constant issues between Diane and Candice for some unknown reason. She told me that she had call Adult Protective Services as she felt Diane was committing self-harm in an attempt to get Candice either kicked out of the apartments or arrested.

Ashley told me she called 911 earlier to talk with an officer.

Reference LSPD incident 2019-13830

Ashley provided me with a written statement as well as numerous email's Diane had recent sent her.

Reference statement - Ashley Sorenson (19 pages)

After I finished interviewing Ashley I returned to my patrol functions until I was dispatched for a Follow Up request from Diane.

I called and spoke with Diane who wanted to know why Candice hadn't been arrested. I again told her that the incident is still under investigation and at this point I was going to forward the case to the Prosecutor for review and a charging decision. Diane became very upset, exclaimed something to the effect that this was the reason why she didn't report it to begin with. As I tried to explain the situation she said something unintelligible and hung up on me in mid-sentence.

Upon returning to the police department I reviewed the provided written statements. I noted in Diane's statement she provided to Deputy Gilje and then in turn to me she wrote she was knocked unconscious for a brief time.

7/10/19

This morning I attempted to contact Kyle Walker at his home but was unable to. I called Candice and asked her to facilitate a meeting with him. She agreed to call him and have him contact me.

At the time of this case narrative I have yet to interview Kyle.

All the photographs taken during this investigation were printed out and then transferred into the LSPD Evidence unit for inclusion into this case.

On Tuesday July 9th 2019 Diane Hildebrandt approached me on the property outside of the H building and said "This is what happens when the system fails you" referring to her battered face. She told me she was attacked by Candice Martin late Sunday night (7/7/19) while she was outside having a candlelight vigil. I asked her if she called the police to report the assault and she told me no, it wouldn't make a difference if she did call them because they never show up. I asked her if there was anyone around at the time of the alleged assault and she told me no, that there were no witnesses. This is the 2nd incident in a month involving Diane Hildebrandt, where she is alleging serious bodily harm by another resident and has not called 911 or reported it to management until days after the attacks occur. I believe Diane Hildebrandt's most recent facial injuries to be self inflicted, as well as the previous injury back in June where she was allegedly stabbed in the laundry room here on the property.

Both attacks Diane Hildebrandt has claimed to have happened by Candice Martin and have occurred at times where staff (myself) is on site and not one time did Diane Hildebrandt come to me to report these crimes until days later, nor have I seen or heard any type of scuffle between the two of them while on this property. Neighbors have also come to my office with reports that debunk Diane Hildebrandt accusations made against Candice Martin. During the time these alleged incidents occur, residents place Candice Martin at other areas of the property.

Since taking this position at this property in May, I have been very busy responding to hand written complaints and emails from Ms. Hildebrandt on a day to day basis. These complaints vary from neighborhood complaints, to maintenance complaints, to residents having no car insurance, or neighbors having unauthorized occupants,

management complaints, etc. Diane Hildebrandt is very involved in the business with her neighbors and this property and demands management to respond to complaints where we have no legal reason to do so. Ms. Hildebrandt, on multiple occasions has verbally told me she plans to hold myself personally responsible for anything that happens to her here on this property.

I have been in contact with Candice Martin since the first alleged incident occurred back in June. Candice Martin has made it very clear to me and others she intends stay as far away from Diane Hildebrandt as possible. She has no desire to have any involvement or interaction with Diane Hildebrandt and knows any type of verbal or physical altercation could put her housing at risk. I do know Candice Martin has been in and out of the hospital for a spinal injury, one that would limit her ability to physically assault another person. Candice Martin has told me she is fearful of Diane Hildebrandt because of these accusations that have been made against her.

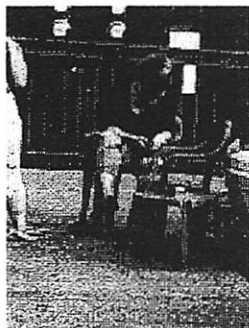

I just want to clarify that when I brought a written statement to you at approximately 11:55 am today regarding tenant in unit G38 Calling me a fucking bitch after you sent out a general notice that chairs ect were not to be placed on the sidewalks blocking other residents from use of sidewalks and other common areas. You accused me of drama but I have only lived here a short time and both the resident in G36 and H39 have been harassing residents here long before I moved here. I know of at least 2 residents who moved away from these two tenants because of the harassment and issues they were caused by these same two residents. I was told by the police on June 25 2019 to video tape and record any further incidents by these residents due to threats and physical harm. I was also told by officer Rutherford that due to the nature of threats by resident Candice Martin that we should not leave our apt we being my 15 yr old son and myself should carry pepper spray for our protection at all times and that Candice is well known by the police for all the issues she causes and is a liar. That is Police Officer Rutherfords quote when I was threatened by Candice Martin. So with this said when I brought a written statement to you today You did not want to take my written complaint for the verbal attack by resident G36 and said you didn't need it for your files. I stated that I was following apt complaint process and you reluctantly took it. You told me you were sick of the drama for which I have not instigated or caused only been a victim of and from my understanding you are basically requesting that I do not file any further complaints against these residents. I am not the one that is in violation of my lease and yet you are suggesting stipulations made by your attorneys if needed and are suggesting that we Have a meeting with myself and these residents that have threatened me and they have been in violation due to harassment not only towards me but multiple residents here long before I moved here . I am not comfortable being in a room with these residents based on most recent threats to have me stabbed rapped and have my son and myself beat up whenever we leave the property without an advocate and an attorney on my behalf present which is almost an impossibility because clear will not provide an attorney to be present and obviously I cant afford one and I do not have any idea how to even get an advocate to be there with me. So it is my understanding that I am not supposed to report these instances of harassment to you even though my lease says that is procedure. You have also stated to me that you cant keep moving people and maybe I should leave which is unreasonable financially impossible and I have an amazing son that is doing great in school and pretty much keeps to himself on the property. I have had many residents tell me how respectful and nice he is and also complimented me on being a great mom. I followed your instructions to let Candice martin know that I did not want to talk to her nor did I want her talking to my son which was what kicked off her making extreme treats towards my son and myself I have done all you have asked but now you are saying I cant even file a complaint if there are further occurrences because what is actual harassment you are calling drama. Just want to make sure we are on the same page. I don't even know why these two residents don't like me or why this behavior from them started almost as soon as I moved in. I do know I will not allow these two residents to force me from my home. You later stated via email that you were happy to accept any written complaints That's quite a contradiction from what you told me in your office. What you did accomplish is making me feel that I can not follow lease procedure when it comes to harassment issues and that you simply are not interested in hearing anything about any of this. Out of 6 buildings I have had consistent non resolved issues of harassment and threats by apt G36 and H39 2 residents I don't even know most of the residents here. You jumped from attempting to refuse my written complaint to stating that I am a good tenant as is my son (Thanks for the compliments) yet within just a few hours of being in your office being threatened with attorney stipulation meetings with residents that have caused great concern to the safety of my family and property. Obviously this would leave me being confused based on your email responses compared to the statements you made to me in your office I can state that there was no misunderstanding as to what you verbally told me earlier today.

Once again I will state I will not be bullied forced or threatened in an attempt to force my son and myself from our home by residents their company or anyone else. I have never had the police called on me do to harassing behavior towards others or any other reason I have never been served a 10 day notice for non compliance I maintain the gardens and my unit at all times My rent is always paid on the 1st or earlier and I promptly report any needed repairs and follow the rules of this property and harassment by two tenants out of 6 buildings towards me is not either instigated by me or encouraged by me. They are in violation for harassment not me and profane threats as well as abusive treatment towards my family yet you get mad at me for following complaint procedure as is stated in my lease regarding these on going attacks. I feel badly for the residents who moved to other buildings because of these two tenants constant harassment and I feel badly for anyone that has to endure their ongoing behavior which has gone on before you were manager and before I lived here. The police get called on H39 all the time and her company . H39s 3 yr old was tested and they found oxycodone in her system. I cant do anything about her drug addiction or the scary part having a 3 yr old taken because she had oxycodone found in a hair follicle test. What I have heard consistently threatened over an extended period is that if anyone reports anything they will get their tires slashed and vehicles fucked up. This statement was heard in a conversation between Dani and Candice and also by Malias husband sons and even Malia. They were not directly threatening me but it was stated that if they have to move from here or you attempt to serve them 10 day notices or report their families to cps they would also slash your tires and fuck cameras that this could happen here on the property or at a store or anywhere else some ones vehicle is parked. Once again Thank You for looking into getting cameras installed.

I have addressed this with you before and it is my understanding that there are several vehicles owned by residents or visitors that are not insured and there are others driving on suspended licenses This puts everyone elses property at risk and I know you are busy but I would very much like to see this issue be addressed. I believe it is a lease requirement to have your car insured. I spoke with Malia yesterday and told her that we should probably just cut ties. I cant continue being involved with anyone that has regular contact with Dani and Candice and although I will miss talking to Malia my son does not interact with her family and we really don't have much in common. This should help cut down on the circle of gossip that never seems to end. (HOPEFULLY) This also may make me a target for all of them which concerns me so I would appreciate you being very careful in including me in any conversations you may or may not need to have with all of them. Please attempt to redirect where a complaint may have come from to help keep my family safe here. Diane Hildebrandt

On Sunday the 7th I was preparing a candle light vigil for a young mom and 3 children that were killed by their step dad the previous Saturday these were children I knew and knew that my friends in port Angeles were planning an all night vigil for the family Sunday so I went to my back patio and set up some candles. I saw no one around my son and dog were upstairs sleeping I had been praying and offering blessings for the family for maybe an hour I looked up and saw Candice Martin with something in her hand but it was dark she proceeded to hit me in the chin Retreat R eye and forehead I was unconscious briefly it was around 2:30 when I went indoors and saw the blood and bruising. I did not call Sunday because I am frustrated with Lake Stevens PD.
