SLADE stated he was falsely arrested by Corporal Fiske and he was injured by Fiske who caused injuries to his left wrist. SLADE stated Fiske called him a "bitch" and "fuck" while transporting him to the Snohomish County Jail. SLADE stated he took photographs to show the injuries to his wrist. SLADE stated he had a red scrape on his wrist the Fiske caused by placing the handcuffs on him to tightly. SLADE stated he wanted to file a complaint and already called his attorney in Seattle to file a civil lawsuit against Fiske and the department. SLADE stated he would come to the department in two hours to fill out the complaint paperwork. SLADE stated the judge dismissed all the charges and let him go after saying sorry for the department falsely arresting him.

I, Cpl. B. Fiske, am a fully commissioned police officer assigned to the patrol division with the Lake Stevens Police Department located in the City of the Lake Stevens, County of Snohomish, State of Washington.

Summary:

Elijah Slade assaulted his 12-year-old nephew, causing an injury to his face. He also kicked 16-year-old Coralynn Charles, causing a bruise to her leg. He was arrested for assault of a child 3rd degree and assault 4th degree.

Narrative:

On May 2nd, 2018, at 0110 hours, I responded to what was originally coded by dispatch as a physical domestic violence call at 9429 N Davies Rd. Dispatch advised the uncle was physical and the reporting party was "wailing." The uncle was described as a black male wearing a black sweater and red shorts.

I arrived with Officer Michael and Sgt. Barnes shortly after the call was dispatched. The "uncle" was located outside the residence. I asked him to have a seat on a ledge and speak with Officer Michael so I could go speak to the other people involved. He initially refused but then he sat down. He kept saying he was assaulted.

I went inside and spoke to multiple juveniles, to include; Jamison Ames (12yoa), Coralynn Charles (16yoa), Vanessa Ames (12yoa), and Brianna Ames (16yoa). Every juvenile was hysterically crying and I had to spend a few minutes to calm them down before speaking with them. One thing I noticed was

Jamison had a small cut on his chin, which he said was caused by his uncle, Elijah E Slade (09/21/1985).

I asked Jamison what happened and he said Slade had been drinking "a lot" of alcohol and they were all trying to sleep and he was being loud and keeping them awake. There was some sort of argument between Slade and Charles so Jamison tried to step in and there was a physical altercation that ensued. Jamison said he tried to push Slade back and then Slade took a swipe at Jamison's face. Jamison showed me with his hands how this looked and I would describe it as a "swipe." Jamison said he was struck in the face when this happened and Slade's nail likely cut his chin. This was later photographed to document the injury.

Coralynn Charles also said she was assaulted. Charles said Slade kicked her in the right shin and it was hurting. She pulled up her pant leg and you could see slight bruising in the area where she described she was having pain. I asked the juveniles if Slade lived there with them and they said no. He apparently has just been staying there for a couple weeks. The three Ames children's father is who is the main tenant at the residence. His name is Brandon Ames, however, he was not present at the time of the initial interviews.

I went back outside to get Slade's side of the story. I asked Slade what his first name was because I had forgot what the kids had told me and he said he was not going to tell me because I would refer to him as "sir." I referred to him as "sir" in our conversation from then on. It was obvious Slade was heavily intoxicated. He was slurring his words, repetitive in his speech, and had a strong odor of intoxicants coming from his breath. I asked Slade what happened and he kept saying he was assaulted but didn't want to "press charges." I asked him to elaborate on the "assault" and he would not. He said "go ask

She said he was extremely drunk and she heard commotion inside and noticed he and Jamison were in a physical altercation. She didn't see how it started but she believed that Slade was the aggressor. Amber is Charles' mother and the girlfriend to Brandon Ames.

Jamison is just over 5 feet tall and only 12 years old. Slade is 6'2 and is much larger than Jamison, as would be expected since he is 20 years older than Jamison.

I went back and spoke with Slade and he said he was willing to leave the house to diffuse the situation. He said his ex-girlfriend was on her way to the residence. I told Slade that I believed if he went back in the residence there was going to be issues and he said he would wait for Brandon Ames to get home. He said he would not tolerate the "disrespect" from Ames kids and Coralynn Charles.

I advised Amber before I left the area that I would be referring charges against Slade and advised it was not a mandatory arrest situation because there was not a domestic violence relationship between the two victims and Slade.

I cleared from the scene but remained close by if there was another problem at the residence. At 0207
