while she was on the phone with her. I told her this is not acceptable, and we expect our officers to be professional. In addition, I told her we hold treating people with dignity and respect is one of our highest values. I told Julie I would inform Sergeant Valvick who would speak to his officers. Officer Rutherford and Officer Kilroy LSPD incident 2020-15887.

Another concern was she felt officers should be there to offer help and guidance at the time of need. Julie thought the officers did not want to hear her niece's side of the story and only took the males side. The fact of the matter was that the female identified as Julie's niece Erika Johnson, was HBD and not cooperating with the officers. Julie told me she knows Erika has a drinking problem, even to the point she got hospitalized the same day as the second incident. LSPD incident 2020-15931 / 2020-15954. She apologized for the rambling email she sent to Chief Dyer as she was upset, and her emotions got to her when she wrote it. Julie thanked me over and over for what we do and for following up with her. I wished her and her niece Erika the best.

Julie was very pleased with the outcome of our conversations and the actions I presented.

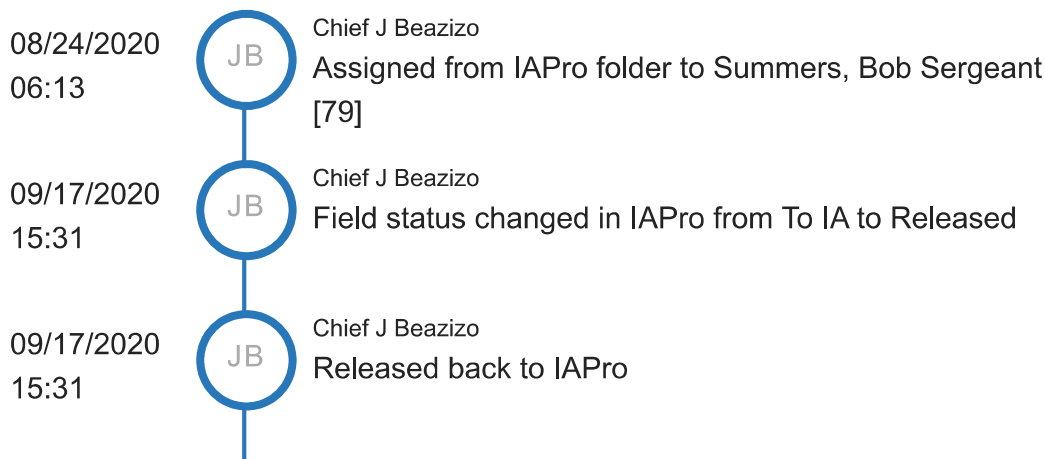

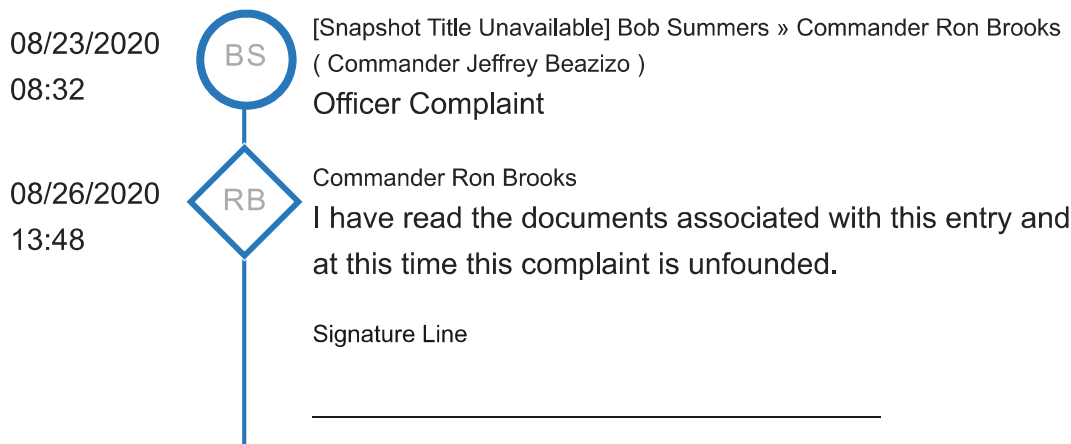

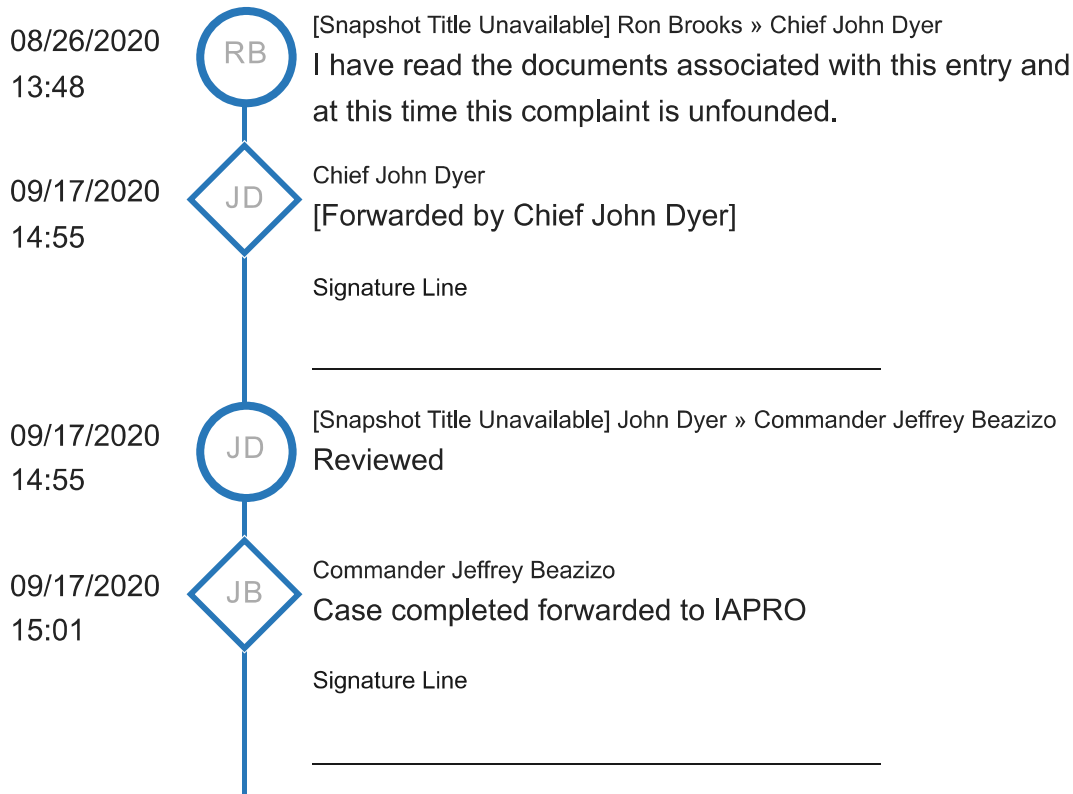

There are two different incidents addressed in this email. The night prior and the next morning. We were only involved in the morning incident and the involved officers were Warbis, Marshal and I. I have don't know about the incident the night before.

At no time during the incident with Officer Warbis, Marshall or I was the color of her skin (it is news to me that she is latin) a factor. Her intoxication level, her hysterics, yelling, rude behavior and refusal to leave the home of her mother in law – were.

I was the officer that took a stern tone with Mrs. Erika Johnson as she was out of control and causing the commotion. At no time was anyone laughing at her.

She had been repeatedly told to leave by the home owner and, at the homeowners request, me. She repeated demanded to know what crime she was committing. I advised her she was trespassing in the second degree and if she refused to leave she could be arrested for it.

Side note – Mrs. Erika Johnson was the female that was stumbling out of Hawkeye's and was Invol'ed for extreme intoxication later in the afternoon.

I will complete a memo on 8/22/2020 that addresses the morning incident in detail.
