Complainant wrote out a statement regarding the incident. Complainant identified both the vehicle and IRWIN in the statement.

IRWIN stated he noticed the complainant riding his BMX bike without any lights, carrying a backpack and with a hoodie pulled over his head near his residence. IRWIN stated he confronted the complainant due to being suspicious in his neighborhood and residence. IRWIN said the complainant asked if he was a cop and IRWIN stated if you lived in this neighborhood you would know that. IRWIN stated the complainant was calling him names and being rude. IRWIN stated the complainant stated he lived in the area so IRWIN got back into his vehicle and left the area. IRWIN stated he would have done it a little differently next time by calling 911 instead of confronting the complainant.

11/15/2019	Chief Jeffrey Beazizo	11/15/2019 1628 hours - I received a telephone call from complainant. Hymes stated he was on his way to work and was heading out near State Route 9 when the incident happened. Hymes stated Officer IRWIN was rude and threatening, cursing at times. Hymes felt IRWIN was unprofessional and didn't know he was a police officer. I explained Hymes IRWIN was a off-duty police officer who was concerned that he was in his neighborhood, riding his bike without a light, and had a hoodie over his head. I explained from a police officers suspicion this could have lead to

		someone who casing the neighborhood and he was concerned for other neighbors. Hymes stated he has a new roommate coming to live with him and he wants to make sure he is not harassed by IRWIN either. I told him if this happened in the future he could call me on my cell phone. I explained I spoke with IRWIN and we talked about a better way of handling something off duty and IRWIN brought up he could have just called 911 and had Arlington PD handle the contact. Hymes was satisfied with that and that I took supervisory action. Hymes thanked me and ended the call.

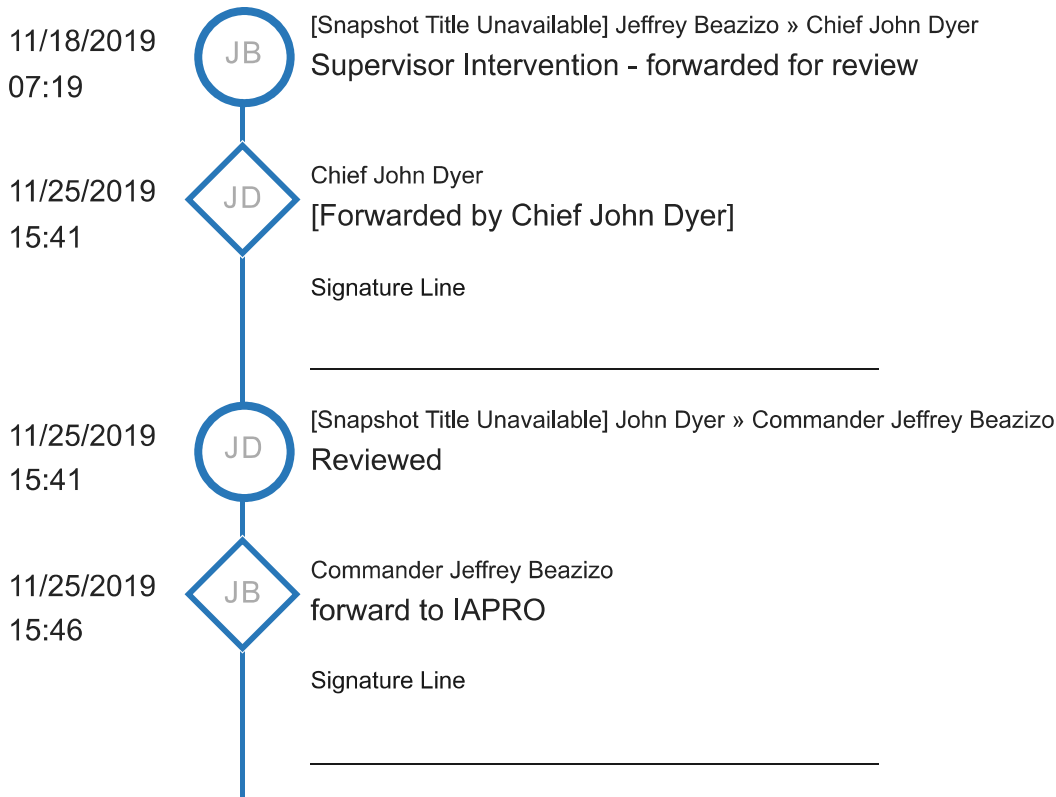

On 11/13/19 I was riding my bike to work when I was stopped by a man in a grey mini van. he blocked the road and demanded to know who I was and where I was going and where I lived. I said you are not the police and I don't have to talk to you. He said he was the police and then he jumped out of his van, approached me in a threatening manner and demanded to know where I lived again. I told him Soana. and then he sped away while I wrote down his License Plate number, the time was Approx 5:00 am, the plate number definitely started with BLV and possibly ended in 9704. I did not dial 911 immediately as I was late to work. He was a darker complexion and bald and heavy-set.

NARRATIVE

At the time of this incident I, Officer M. Ingram RL1157, am a fully commissioned Police Officer assigned to the Arlington Police Department, Patrol Division.

On 11/14/2019 at approximately 1439 hours I was dispatched to a walk in complaint regarding a suspicious incident at our office. I contacted V-1 Roy R Hymes (04/10/1985) who is the reporting party. Roy told me that he was riding his bike to work yesterday morning (11/13/19) around 0500 hours in the 200 block of Joann Lane Arlington, WA. ROY resides at 210 Joann Lane.

ROY said as he was riding his bike he observed a Silver, nicer newer model type van pull directly in front of him. ROY said the listed vehicle blocked him from riding his bike any further. ROY stated a man described as a darker complected, bald and heavier set male started who was driving the listed vehicle demanded to know who he was, where he was going and where he lived.

ROY told the above described male that he did not need to tell him who he was or where he lived. ROY described the male as wearing normal clothes and told him he did not have to tell him anything because he was not a police officer. ROY said that was when the man replied that he was a police officer and as he did so he jumped out of his vehicle.

ROY told me the male then approached him in a threatening manner and at time ROY thought there was going to be a potential fist fight. ROY said the man continued to demand to know who he was and where he lived again. That was when ROY said he lived off of Joann Lane and then the male jumped back into his vehicle and sped away.

ROY said he immediately wrote down on his phone the license plate to the listed vehicle. ROY was positive that the license plate started with BLY and said he believed the rest was 9704. ROY said he regretted not calling 911 but stated he was going to be late to work and described the listed incident with the male subject to last approximately a minute to two minutes long.

ROY told me he came in to report this incident today because it really shook him up and he was shocked it happened. ROY explained to me that he felt detained by the male subject and while the male had exited his vehicle he had to get off of his bicycle and place it between the two of them to create distance for protection. ROY said he felt like the best thing to do was to report this because he felt the male was impersonating an officer. ROY advised he would be able to positively identify the male if necessary.

ROY completed a written statement. I ran a records check on the plate provided and it returned to a 2016 Silver Honda Pilot registered to Dennis and Diane Irwin with a listed address of 233 Joann Lane Arlington, WA. I immediately recognized the name of Dennis Irwin as a Police Officer for Lake Stevens Police Department. In addition the above description provided by ROY fits the general description of Dennis. At that time I notified Sgt Barrett of the above listed incident.
